

### **Placement**

- Install the unit within base unit range in an indoor environment. We recommend installing the unit in a raised position (such as on a wall).
- Avoid positioning the unit close to objects that will interfere with reception, such as thick walls, radiators, metal shelving, etc.
- For maximum distance noise-free operation, place the unit away from electrical appliances such as TV, radio, personal computer, or other telephone equipment.





### Installation/Registering the range extender to the base unit


- 1 Range extender: Connect the AC adaptor to a power outlet.
  - Use only the supplied Panasonic AC adaptor PNLV226.
  - When the unit is turned on, the STATUS indicator and ♥ indicator light amber for about 2 seconds.
  - If the range extender is not yet registered, the STATUS indicator lights amber. If the range extender is already registered, the STATUS indicator lights red while the ♥ indicator flashing red.









- Depending on the base unit, a registration tone sounds.
- If all registered handsets start ringing, press the same button to stop. Then repeat this step.
- The next step must be completed within 90 seconds.
- 3 Range extender: Press and hold [PROGRAM] for about 3 seconds to enter the registration mode.
  - When the unit is in the registration mode, the STATUS indicator flashing green.
- 4 Range extender: Release [PROGRAM]
  - The STATUS indicator continue flashing green while registering.
  - After registration complete, STATUS indicator and ♥ indicator light amber for 2 seconds. Then, the STATUS indicator lights red while the ♥ indicator flashing red before registration complete.
- 5 Range extender: Confirm that the STATUS indicator and  $\Psi$  indicator light green. (The unit is ready for use.)
  - If the indicators do not light green, re-position the unit in a place where the indicators light green.











- 6 Base unit: To exit registration mode, press [LOCATOR].
  - Depending on the base unit, it will automatically return to standby after registration completed.

#### Note:

- The AC adaptor must remain connected at all times. (It is normal for the adaptor to feel warm during use.)
- The AC adaptor should be connected to a vertically oriented or floor-mounted AC outlet. Do not connect the AC adaptor to a horizontally oriented AC outlet that faces the floor, such as an AC outlet installed on a ceiling or under a table, as the weight of the adaptor may cause it to become disconnected.
- The unit can support a maximum of 2 handsets at a time.
- Up to 2 range extenders can be registered to the base unit.

### Deregistering the range extender from the base unit


- 1 Unplug the AC adaptor from power outlet, then press and hold [PROGRAM].
- 2 While pressing and holding [PROGRAM], re-connect the AC adaptor.
  - When the unit is in the deregistration mode, the STATUS indicator flashing red.
- 3 Keep pressing and holding [PROGRAM] for about 10 seconds until the STATUS indicator light red. Then release [PROGRAM].
  - After deregistration complete, STATUS indicator and Y indicator light amber for 2 seconds. Then, Y indicator lights off.























Problem	Cause/solution
The unit does not work.	When the indicators do not light, the AC adaptor is not connected properly. Check the connections.  When the indicators do not light green, move the unit closer to the base unit.  Registration may have been canceled. 



The range extender and other compatible Panasonic units use radio waves to communicate with each other.
